CHAIR OF THE BOARD REPORT

Bill Greene, Chair of the Board

I would like to begin by recognizing the Indigenous People of British Columbia and Yukon and thank them for sharing their homeland with us.

I would like to welcome our new CEO, Cam Hope and his wife, Sara, who joined the BC Hockey family this past fall. Cam is a lawyer who brings a strong hockey background, having worked with the New York Rangers in the NHL and more recently with the Victoria Royals of the Western Hockey League. Cam is an excellent fit for our organization, and he will continue the work the Board started in conjunction with all stakeholders in building the “New” BC Hockey a little over a year ago. Cam has been working with the Board of Directors to understand better the landscape, needs, and requests of our members in all areas of BC Hockey. Cam is an excellent thinker and strong communicator. He has wasted no time rolling up his sleeves and leading our staff to keep this important work moving forward while looking ahead to our future.

This season ran under similar conditions as the end of last season with more unforeseen delays because of health regulations and restrictions imposed by the Provincial Health Authorities in all areas of our operation. Our staff reviewed health information daily and updated our plan to ensure we could get players back on the ice as quickly as possible. We took advantage of the pause in hockey to begin improving our customer service and communications with all Districts and stakeholders. We will continue to collaborate with all levels of hockey. No one could have ever estimated the enormity or complexity this virus has created while organizing hockey for youth in BC Hockey. Our office staff worked closely with viaSport and other entities to ensure we were compliant with Dr. Henry and Premier Horgan’s plan to help us safely navigate through COVID-19. Dr. Henry and Premier Horgan’s demonstration of leadership, commitment, and empathy has energized and helped all of us through an unprecedented time. Never in the hundred-plus years of BC Hockey’s history has any group had to endure what we have experienced. I know this has made us stronger as an organization and set us up for a bright future. Our dedicated players, coaches, parents and volunteers were incredibly patient while demonstrating how great a job we can all do when we work together.

As I stated to you in my address in April, I have had an opportunity to speak with many of you in all districts, and again I want you to know how very proud I am of the great work done by all of you. No matter how tough things became, everyone pulled together to get kids playing and helped provide a needed sense of normality and some exercise in their young lives. I have seen pictures of smiles on the faces of our youth while on the ice. Your generous gift of time to the game has made this possible. On behalf of the players, coaches, volunteers, and parents, I extend my heartfelt thanks to all of you. Your efforts have made a significant difference.

On behalf of the Board, I have reached out to you through videos on several occasions this season; you can expect to see more of this open communication as we move forward. These videos will serve as a lasting reference to where we have been, where we are at, and where we are going.

OPERATIONAL REPORT

Cameron Hope, BC Hockey Chief Executive Officer

Last year's Operational Report was crafted by Jeremy Ainsworth and Jennifer Cheeseman. At the time, Jeremy and Jen would have been neck deep in navigating the BC Hockey office through a real storm, a true crisis, and I think it is fair to say that this was reflected in the tone of the Report. Here is what I remember about it; there was recognition that our volunteers are the backbone of our game, which of course is always true. There was reference to the challenges of the pandemic, of using the time for reflection, and of opportunities that lay ahead. The report spoke of a renewed focus on Member engagement and inclusion, and it expressed gratitude for the commitment of the membership during 'difficult times.' We were half a year into the pandemic at that point.

Overall, that 2020 Report was brief, and it was cautious. Something Jeremy and Jen did not mention in last year's Report was that part of protecting the organization called for them to reduce BC Hockey's office staff by two-thirds. It required that they spend difficult hours in the hardest kinds of meetings, saying goodbye to more than 20 friends.

I was reading the Report last year from the perspective of being, at the time, a candidate for the CEO position at BC Hockey. I was interested in learning everything I could learn about the organization, and I remember thinking at the time that whoever became the CEO should be able to write a much different 2021 Operations Report. It would be full of congratulations and celebrating a rebound season in 2020-2021. It would be a Report filled with optimism, because we would surely all be through the worst of the pandemic. Well.

In October I was honoured to accept the CEO position and join the BC Hockey team. I joined an organization in transition, to say the least. Changes to BC Hockey were already underway. The BC Hockey Board had committed to a fresh approach to hockey stewardship in BC and Yukon. The message from our Members had been clear; it was time to refocus on what our Members most valued. It was time to support the grassroots game, to return to common sense at every opportunity, and build far better communication. It was time for BC Hockey to be a leader, to be strategic and smart, and get things on track.

As we moved from fall into winter, and COVID-19 refused to abate, our trimmed-to-the-bone staff and hundreds of exceptional volunteers all over the province went to work creating the best possible hockey experiences in the circumstances. They do so because of our promise to add something positive to their lives through participation in our game. It is a promise to deliver on our core values of teamwork and integrity and excellence. And fun, especially fun.



STANDING COMMITTEE REPORTS

Finance Committee

The Finance Committee held five (5) meetings since the 2020 BC Hockey AGM, two (2) in November 2020, one (1) in January, March, and May 2021. During this time, the committee reviewed bi-monthly financial reports and statements, recommended the approval of the 2021-2022 BC Hockey budget, and the March 31, 2021 Financial Statements to the Board. Additionally, the group considered and brought forward recommendations to the Board of Directors as follows:

- Changing our Policy amounts of meal per diems, and KM rate for mileage to be in line with Canada Revenue Agency,
- Refunding 50% of our Participant Assessment Fees to MHAs,
- Providing a credit to Officials that Participated in the 2020-2021 season of \$74, or \$50 depending on whether they paid a Participant Assessment Fee in the 2020-2021 season, this credit will be used in the 2021-2022 season.

The committee will be meeting every two (2) months during the remainder of the pandemic to discuss and review any financial items arising from COVID-19.

Governance Committee

Grant Zimmerman, Committee Chair

Although we got off to a late start because of the Covid-19 Pandemic, the Governance Committee has had another busy year. The focus of our year to date has been to:

1. Conduct a review of BC Hockey's Bylaws and Regulations; and
2. Prepare the Resolutions Package for the 2021 Annual General Meeting.

Such tasks have taken considerable time and effort and have delayed us from getting on with the balance of our 2020-2021 Workplan.

In addition to the above, the Governance Committee also reviewed the Member submitted resolutions as part of our regular tasks. This year there were two (2) resolutions put forward by Members. One of the resolutions related to Championships for Junior B which forms part of the resolutions going forward at the 2021 Annual General Meeting. The other resolution which dealt with playing rules and suspensions was identified to be out of order as a Bylaw amendment and was referred to the BC Hockey Referee in Chief for attention. The Governance Committee worked with the Member submitting the



resolution to identify a more appropriate path to advocate for changes to playing rules. As a result of discussions with the Governance Committee and BC Hockey Staff, the Member withdrew the resolution and decided to pursue a different process to advocate for change to the playing rule in question.

2020–2021 WORKPLAN FOR THE GOVERNANCE COMMITTEE

The Governance Committee developed and adopted a 2020–2021 Workplan. Highlights of the 2020 - 2021 Workplan include:

1. **Review Bylaws and Regulations** – This ongoing project of the Governance Committee being led by Michael Marson was started in 2018 and we made significant progress on it this year. The Governance Committee has focused its attention since 2018 on making revisions to the Bylaws and Regulations to fix typos, clean up defined terms and fix inconsistencies to clarity and consistency without materially changing any meanings or interpretation within the Bylaws and

Regulations. Our goal is to make the Bylaws and Regulations easy to read and understand. You will see a resolution to support this project in the Notice of Motions for the 2021 Annual General Meeting as Resolution 2021 – 06. We hope that you will support the Governance Committee in its work by supporting this Resolution.

Once we have completed the comprehensive clean up, we will continue to work on additional more substantive issues in the Bylaws and Regulations. We have already identified a number of areas where the Bylaws and Regulations are not clear or consistent, but the changes required are changes which could impact their meaning or interpretation. A strategy to resolve these issues which will involve engagement with the Members is being developed. You should expect to hear more about this project next season.

2. **Strategic Plan** – The Board of Directors changed its strategic planning process in 2018-2019 which led to the development of the Strategic Direction which the Board unveiled at the 2019 Annual Congress. The Board and Staff of BC Hockey have been developing the Strategic Plan since the unveiling of the Strategic Direction. The process was sidelined as a result of the pandemic and a change in the BC Hockey CEO as the Board of Directors dedicated significant time and effort to manage the organization and recruit a new CEO. Since Cameron Hope was hired as CEO there has been significant time and effort dedicated to the development of the Strategic Plan and everyone is looking forward to its unveiling. As the Governance Committee is responsible to “propose the method and timeline for strategic planning”, the Governance Committee is keenly observing and following the strategic planning process being utilized by the Board.



3. **Appeal Process** – The Governance Committee, led by one of our members, Brad Kielmann, conducted a review of the appeal procedures in our Bylaws and Regulations. The Governance Committee made recommendations to the Board which resulted in a resolution coming forward to the Members at the 2021 Annual General Meeting. It is Resolution 2021 – 04.

4. **Review of Member Obligations** – This is an ongoing project and there are a number of items that have been identified under this topic. Two of these items are outlined below:

a) **Evidence of Incorporation and Good Standing** – This item is moving forward as part of the Resolutions Package for the 2021 Annual General Meeting. The Governance Committee originally identified that some of our member Minor Hockey Associations are acting as unincorporated associations and not registered societies under the *BC Societies Act*. Starting in 2019, BC Hockey has been asking Members to provide evidence that they are registered and in good standing. Through such process we have confirmed that a number of our Members are not registered in good standing. The Governance Committee believes that unincorporated associations have too much potential liability for its organizers and create potential liability for BC Hockey. Discussion arising from this resulted in the Board passing a motion at the December 3, 2019 Board of Directors Meeting directing the Governance Committee to draft changes to the Bylaws and Regulations to require members to produce evidence that they are incorporated under the *Societies Act* or *Business Corporations Act* or other applicable legislation. The Governance Committee has developed the appropriate resolutions for this year's Annual General Meeting, and you will see them in the Notice of Motions as Resolution 2021 - 05.

b) **Team Officials and Criminal Record Checks and Other Obligations** - Another of the topics identified by the Governance Committee under the heading of Member Obligations was to make sure that BC Hockey has the authority to require all appropriate people in hockey to meet certain member obligations including the providing of criminal record checks. We identified that the definition of Team Officials needs to be clarified to make sure it includes Owners (in the case of Junior Hockey Teams and Hockey Canada Accredited Schools for example) as they come in contact with youth. The Governance Committee has identified that BC Hockey's Bylaws and Regulations are inconsistent and unclear as to who are team officials? As well as being unclear and inconsistent, the definition of Team Officials does not appear to be complete or adequate to capture all those who participate in team management and operations. Hockey Canada has a different list, but the Hockey Canada definition of Team Officials may also not be sufficient. The Governance Committee is still working on this issue and intends to provide recommendations and guidance to the Board in the future.

5. **Hockey Canada Accredited Schools (HCAS):** Hockey Canada enacted its new HCAS Policy in 2020. One of the significant changes arising from the new HCAS Policy is that Hockey Canada Accredited Schools are to be registered as Members and regulated by their respective Hockey Canada member Branch. To date, Hockey Canada Accredited Schools have not been direct members but have been affiliated with a Member Minor Hockey Association. As a result, the Governance Committee has recommended changes to the Bylaws and Regulations to make Hockey Canada Accredited Schools members of BC Hockey. This is presented as one of the resolutions for the 2021 Annual General Meeting. It is Resolution 2021 – 02.

6. **Hockey Canada Age Divisions:** At the request of the Board, the Governance Committee has drafted revisions to the Bylaws and Regulations (thanks to Michael Marson) to deal with Hockey



Canada's adoption of new age division classifications. The Governance Committee made recommendations to the Board which have resulted in one of the resolutions for the 2021 Annual General Meeting. It is Resolution 2021 – 01.

7. **Minimum of two (2) Male and two (2) Female Directors:** As a result of Hockey Canada's adoption of a minimum two (2) male and two (2) female directors, the Board asked the Governance Committee to draft and recommend changes to BC Hockey's Bylaws to adopt minimum two (2) male and two (2) female Directors. The Governance Committee made recommendations to the Board which have resulted in one of the resolutions going forward at the 2021 Annual General Meeting. It is Resolution 2021 – 03.

WORK GROUP REPORTS DIVISIONAL COMMITTEES

Adult Male Committee

Trevor Bast, Adult Male Coordinator

Senior AA

Senior AA Season did not get started. Coy Cup was cancelled for the second consecutive season. As of this day, four (4) independent teams plan on playing, if subject to public health guidelines. CIHL hasn't spoken as a league since Dec, there is no indication of what shape teams are in. Planning is underway for a 2022 Coy Cup, possibly at a neutral site.

BCIHL

Trinity Western left at end of 2020 season for USport. Teams began practicing under allowed parameters in September 2020. Several target dates and plans for an abbreviated season were pitched but due to worsening COVID-19 situation, none of these targets were met and the season was ultimately cancelled. In March 2021 Selkirk College announced the disbanding of the Hockey program resulting in three (3) remaining teams. Also in March 2021, UBCO was approved for expansion for fall of 2021. Expansion conversations are also ongoing with the University of the Fraser Valley and Thompson Rivers University.

Junior Committee

Keegan Goodrich, Junior Coordinator

Junior hockey in BC consists of 42 Junior B teams made up from three (3) leagues, the Kootenay International Junior Hockey League (KIJHL), the Pacific Junior Hockey League (PJHL) and the Vancouver Island Junior Hockey League (VIJHL), and 18 Junior A teams in the BC Hockey League (BCHL). In addition, there were two (2) BC-based Junior B teams, Dawson Creek Junior Canucks and the Fort St. John Huskies, that played in the North West Junior Hockey League (NWJHL) based out of Alberta. Due to COVID-19, several teams were not able to compete or decided to opt-out of playing for the season.

Restrictions on sporting activities affected hockey at all levels, including junior hockey which relies on travel to compete therefore leagues were affected greatly due to the COVID-19 Pandemic.

Limited game play was permitted in cohort groups for limited contact tracing and travel.

Junior B





The three (3) BC Hockey junior leagues all were able to play a minimal number of games with the KIJHL only able to play between two (2) and four (4) games per team with a regular season that started in November but quickly halted with travel restrictions. Prior to the start of the season, the PJHL welcomed their 13th franchise, the Chilliwack Jets, as an expansion team. The PJHL teams were able to play between two (2) and eight (8) regular season games while the VIJHL teams were able to play between 11-13 games, starting their season in October.

Junior B teams continued to try and give their players the ability to practice throughout their seasons withing the Provincial health guidelines.

The 2021 Cyclone Taylor Cup was cancelled on January 5, 2021.

Junior A

The BCHL held exhibition games within their cohorts at the start of their season until gameplay and travel were paused. They worked closely with the Provincial Health Authority to resume gameplay in April within pod locations.

Minor Committee

The Minor Committee is comprised primarily of the BC Hockey District Presidents and a representative from the Board of Directors. Our mandate is to advise the Board of Directors on recommendations affecting minor hockey in British Columbia, in accordance with key duties outlined in the Minor Committee Terms of Reference.

This past season the Minor Committee met over 12 times via video conference since last September. With Covid impacting minor hockey in the province and across the country, minor committee took a proactive role in discussing pertinent topics to support improvement of the game at the minor level as well as providing recommendations to the board.

The Minor Committee discussed and provided input on the following topic areas:

- District challenges related to COVID-19
- Minimum suspension guidelines
- Recommendations for carry over suspensions
- AA/AAA costs and budgets
- BC Hockey Championships
- Championship host rotation
- Female Hockey Task Group
- Minor Hockey Tier Designation Work Group
- Alignment of Operations to BC Health Regions
- Member engagement meetings
- Registration redundancy review
- U17 AAA proposal
- Exemptions to Hockey Canada regulations



Minor Committee was also introduced to the new CEO Cameron Hope and had multiple conversations with Cam on the state of BC Hockey and the strategic direction of the organization.

I would like to thank Vice Chair, Chuck Gallacher, for a second straight year for his leadership. Many thanks to all committee members for the productive conversations and their dedication to minor hockey across the province.

Championships

The BC Hockey Discipline Task Group's responsibility was to administrate the documentation of suspensions within the Hockey Canada Registry for participants that were penalized with match, gross or refusing to start play infractions at the minor hockey level. They were to complete any applicable investigations and notify the participant of their corresponding suspension. This is the fourth season for Byron Rice as a Coordinator and fifth season operating with this task group.

The online game incident reporting system, as well as the online game sheets, worked extremely well this year. The information on both reports make it very clear and simplifies the reporting system. We appreciate the task group members hanging in there this season thru all of the ups and downs. The task group members completed all of their suspensions in a timely manner.

Overall, the BC Hockey Discipline Coordinator noted that the task group was very conscientious and worked hard to keep up with the necessary investigations. Positive feedback was received from the district and minor hockey associations. The Discipline Task Group utilized BC Hockey Bulletin 2020-010



- “Minimum Suspension Guidelines – Minor Female” to complete their administrative duties. The summary below outlines the incidents processed by the group members.

‘Upon the implementation of Public Health Orders in the Province of BC in early December 2020, there ceased to be any further duties for this group as game play was paused. In Yukon, game play continued and Byron Rice continued with the administration of applicable discipline within that area of the membership for the remainder of the season. “

Indigenous Participation Work Group

The Indigenous Work Group has been meeting since December approximately every two weeks discussing strategies that BC Hockey could explore in order to improve inclusivity of Indigenous participants within programming. The workgroup consists of the following members:

As a result of the groups meeting discussions, three (3) opportunities have been determined as focus items:

Focus Item # 1:

Inclusion of the Aboriginal Coach Module (ACM) into our current coach education offerings.

Status:

Staff from BC Hockey and ISPARC have been reviewing the curriculums, virtual platforms, and logistics to implement this professional development. While there are a few items to sort through, we feel there is a great opportunity to provide coaches with an increased awareness of Indigenous culture. Hopefully, this program enhancement can be introduced during the 2021-2022 season. We will continue to update the Membership on our progress in this area.

Focus Item #2:

Provide a virtual seminar on Indigenous cultural safety training for Minor Hockey Associations.

Status:

ISPARC has recommended Indigovation Consulting Inc. as a group that can facilitate a virtual webinar in the summer of 2021. By working with our Districts, up to twenty interested MHAs would identify



leads to attend this workshop. Selected MHAs are to be associations that are serious about building relationships with Indigenous Communities and are willing to follow through with a secondary step that has a liaison assist with facilitating and encouraging relationship building.

Workshop goals include the following topics:

- Workshops that provide knowledge and understanding of Indigenous history and training to build understanding of the need for cultural safety
- Setting a tone for safe conversations - trust and relationship building
- Experiential learning that deepens the learning, understanding and ongoing impact of the country's history and the strained relationship between Indigenous and non-Indigenous people
- Examination of how practice and systemic cultures contribute to ongoing barriers that exist deconstructing policies and practice standards – how to move forward in a good way that can support collaboration
- Encourage examination of organizational culture and what might be important to strengthen Indigenous – non-Indigenous relationships and shift attitudes through Indigenous conflict management strategies
- Building connections for participants for inclusion of Indigenous communities and organizations, and importance of building sustainable relationships between Indigenous and non-Indigenous communities
- Guide organizations to consider Indigenization initiatives, to reduce barriers for Indigenous people
- Encouraging organizations to consider beliefs and values Indigenous peoples hold and how they can contribute toward successful business practice.

Focus Item # 3

Development of an Indigenous Relationship Liaison – Volunteer Position

Status:

A job description has been developed for an Indigenous Liaison. The primary responsibilities of this position are to assist with the development, implementation, and evaluation of an indigenous participant strategy. The selected candidate would work directly with Minor Hockey Association's that attend the virtual seminar to initiate and assist with the building of quality relationships within their communities. Reporting and evaluation of progress would also be in the scope of duties.

Minor Hockey Operations Task Group

June McKenzie, Minor Hockey Operations Coordinator

This was a season that I haven't seen in my 35 years of involvement with minor hockey. Thank you to everyone who worked so hard to safely get players on the ice with the restrictions in place.

This season the Minor Hockey Operations Task Group consisted of eight (8) District members, a Branch Coordinator, and a staff resource. The Lower Mainland had two (2) members, Kootenays had one (1) and all other Districts had one (1) each. Since there were no tournaments, we had no tournament team or recreational player relief requests. A few residential waivers and carded goaltender transfers were approved early in the season. We continued with our video conferences during the season.

There were a few changes this season affecting our task group duties:



1. Goaltender transfers for recreational hockey were dealt with at the District level. There was no change to goaltender transfers for carded teams which continue according to BC Hockey Policy 9.08.
2. Approval for movement of U9 age players to U11 teams was dealt with at the District level. Previously these requests were dealt with by task group members and me, with input from the District.
3. When I did the final review of transfers and residential waivers requiring input from the District, the District Task Group Member and me, I was able to finalize the transfer in the HCR.

These changes streamlined the processes, so requests could be processed a bit quicker.

Thank you to all the task group members, District Presidents and Brianna Davey our staff resource.

Minor Relations / Communications

Dave Buck, Minor Relations / Communications Coordinator

It has been my pleasure to serve as your Minor Relations and Communications Coordinator this past year.

The volume of complaints and requests was much less this past hockey season due to the limited practice and playing time because of restrictions imposed to attempt to curtail the worldwide COVID-19 pandemic. That being said, we were tasked with several interesting topics and problems to help provide direction to and or provide mediation. These have included answering member's questions on where to find resources, complaints of:

- bullying and harassment accusations.
- unfair evaluation and placement of players on teams.
- potential coaches feeling they have not been properly evaluated or given detailed reasons as to why they were not selected to coach a team from previous years.
- adults unwilling to accept the fact that MHA's have a right to decide who should be appointed to their board.
- Members feeling their concerns were not addressed properly because some volunteers on MHA boards held more than one position within the MHA.

I want to commend our Board of Directors and support staff for their leadership and very difficult decisions that have had to be made during these several months.

I look forward to serving our Membership in 2021-2022.

PROGRAM COORDINATOR AND COMMITTEE REPORTS

Coaching

Dave Cunning, Manager, Athlete Development

Despite the setbacks that COVID-19 set upon all BC Hockey programming, 2020-2021 was still very productive season in the Coaching department. The efforts of our dedicated and synergistic group of clinic facilitators, evaluators, and coordinators within the Coaching Program Delivery Group worked together to see our clinic season through, albeit with a modified approach to clinic delivery.

Clinics





COVID-19 forced us to pivot to online delivery for our coaching and specialty clinics. This involved facilitators and evaluators from the Program Delivery Group undergoing a training process led by Hockey Canada to equip them with the necessary skills to be able to deliver coach education over Zoom. Coach 1 and Coach 2 started fully online, while Development 1 was split into two (2) parts, with the first being online and the second in-person. Once PHO orders made hosting Dev 1 Part 2 in-person no longer possible, it was also migrated to an online format.

Following lowered player registration trends at the recreational level, Coach 1 and Coach 2 coach clinic registrations followed in kind, posting 79% and 87% respectively as compared to 2019-2020 registrations. With that in mind, we still saw an increase in overall clinic participants at the Development 1 level than last season however, posting nearly a 4% increase in registrants as compared to 2019-2020, despite reduced game play (statistics below).

For the first time, all coaching clinic materials (reference materials and post-tasks) were made digital rather than hardcopy. These digitally fillable and downloadable files were posted to our website, and clinic delegates were to access them for use before, during, and after their clinic. We intend to move forward with online delivery for some components of future clinics, but also hope to return to face-to-face delivery for others – we will continue to monitor PHO orders and well as Hockey Canada recommendations to determine our delivery methodology in 2021-2022 and beyond.

BC Hockey was forced to cancel the 2020 High Performance 1 (HP1) Seminar but will be facilitating the 2021 event online this summer. Online delivery will allow delegates from all over to participate in the clinic in hopes of obtaining the highest level of certification Hockey Canada offers. BC Hockey completed a number of HP1 field evaluations early on in the 2020-2021 season before PHO orders restricting game play stalled the process, rendering coach evaluations at games no longer possible to complete.

Female Coach Development

In partnership with Hockey Canada, three (3) female BC coaches (Christina Sharun, Nancy Wilson, Whitney Juszewicz) started along the pathway to becoming Women's Master Coach Developers (WMCD) through the Coaching Association of Canada in 2020-2021. This led to the facilitation of a female-only, We Are Coaches, Coach 2 clinic in February by our newly minted WMCDs this past season. Moving forward, we aim to utilize our WMCDs to facilitate We Are Coaches clinics at all levels of certification with a much higher frequency in hopes of spurring greater female coach engagement with our programming.



We also saw three (3) female BC coaches (Amanda Sargeant Levesque, Amy De Bree, Whitney Juszewicz) engage with the NHL Coaches Association (NHLCA) last season through their Female Coaches Development Program.

Specialty Clinics

NCCP Instructional Stream Specialty Clinics were also repurposed for online delivery in 2021, and we successfully delivered Level 1 of Goaltending and Skills, with plans to add Developing Defencemen to the rotation. Delegates from the Hockey Canada Skills Coach and Hockey Canada Goaltending Coach certification programs were utilized as facilitators for these clinics, which allowed them to complete components of their certification tasks and work towards completion. These new facilitators were mentored by our veteran facilitators, and will be looked to for future delivery of Instructional Stream clinics.

Mentorship

In an ongoing effort to offer coaches continued support through the hockey season beyond the clinics they attended, BC Hockey's Coaches Club returned for another year. This professional development initiative invites coaches at all levels to engage in discussions with some of hockey's most knowledgeable and experienced coaching leaders. Guest speakers from last season included:

These online sessions provide professional development points for Development 1 and HP1 certified coaches as part of the Hockey Canada coaching certification maintenance program and serve as a great resource for anyone with an interest in coaching development. The program has attracted over 500 registrants since its inception in November 2019. Select sessions have been posted to the BC Hockey YouTube channel for ongoing consumption.

Additionally, we were able to once again offer our coaches access to mentorship webinars hosted by the NHL Coaches Association (NHLCA), stemming from our working relationship with the Association that began at the 2019 NHLCA Global Coaches Clinic at the 2019 NHL Draft in Vancouver.

Furthermore, BC Hockey teamed up with ISPARC in March to present a speaking engagement featuring Brigitte Lacquette from Team Canada's National Women's Team. Lacquette was the first Indigenous hockey player ever to be named to Canada's NWT, and won an Olympic silver medal with Team Canada in 2018 at the Pyeongchang Olympics. The Zoom call was attended by an estimated audience of 80 Indigenous and non-Indigenous players, coaches, and their families. This session is the first part of a planned series and ongoing partnership with ISPARC that will feature Indigenous players and coaches as future guest speakers.

Coaching Advisory Group

The Coach Advisory Group – comprised of coaches from minor hockey, AAA, the BCHL, the WHL, Hockey Canada Skills Academies, and Hockey Canada Accredited Schools, and our Coaching Program



Delivery Group – corresponded over the season for discussion and formulation of recommendations for the improvement of future programming, as well as adjudicating recipients of the Ernie Gare Coach of the Year Award and the Development Award for Coaching.

Female Hockey Development

Jennifer Loewen, Female Hockey Development Coordinator

The 2020-2021 season saw the push for female hockey to be a top priority from the Board of Directors. Early in the season the Board of Directors tasked out the review of the female model with a goal to customize by district to allow for a more effective approach across the province.

All the Female Zone Leads have been reappointed for the 2021-2022 with an addition of a Zone Lead in the East Kootenay. They will be reaching out and working very closely with our Minor Hockey Associations and Districts and begin planning for the upcoming season.

A major component of the review of the Female Model included the creation of a Female Task Group. Comprised of a representative from every District in the province, extensive work has been done over last six (6) months. The group has met four (4) times to brainstorm and create plans to increase female registration across all Districts. The Task Group has focused on a number of items in a phased approach to successfully launch the revised Female Model for the summer of 2022.

Phase 1: (August 2021)

- Recruitment initiatives – each District will have a recruitment plan specifically set out for their area. The Task Group realizes that what works in the North may not work well in the Lower Mainland and as such, customized plans considering these unique differences have been taken into consideration.



- Officiating – female officiating education module. It was recognized that officiating did not take into account the specific differences of the female game. With this in mind, a breakout group has created recommendations to address these differences and will work towards adding these components to the officiating certification.
- Mentorship – mentorship plans for AAA and CSSHL players and coaches to work with MHAs
 - MHA teams to work with younger divisions within their organization. Across all areas if discussion, mentorship was one of two top topics. A breakout group was tasked with creating a pathway for mentorship by elite players to other female players. In addition, female MHA teams will also be asked to work with younger divisions within their organization.

Phase 2: (October 2021-February 2022)

- Female Coaching Recruitment – Recognizing the lack of female coaches and specific coaching education specific to the female game, a diverse group was brought together to tackle recruitment initiatives. These initiatives must be able to be facilitated at the local level or the branch level to increase female coach recruitment in local MHAs (both female and integrated associations)

Phase 3:

- Female Minor Hockey Association Best Practices – best practices document is being create to make it easier to create Female Hockey Associations if registration numbers allow for it.

The following goals have been set out by the Female Hockey Program moving into the 2021 season:

- To work to remove the barriers and become the Province that the rest of Canada looks to and says ‘wow, they made history for female hockey. Let’s be more like BC’.
- To survey current female hockey players, both A, C and AAA levels, to determine what their needs are and what they have found to be punitive in their experiences.
- Work towards establishing ‘female hockey’ collaboratively which means thinking outside of district boundaries and conventional integrated hockey thinking.
- To have the Female Zone Leads work as an enhancement in each District to support MHA’s as they work to build their capacity and communication.

We are looking forward to working with our Zone Leads throughout the summer to build on these goals and make the adjustments to the Female Model a reality in all BC Hockey Districts and MHAs.

Female AAA and Male AAA Programs

The 2020-2021 season took place amidst the COVID-19 pandemic. BC Hockey worked in conjunction with Hockey Canada, and viaSport to ensure the safety of our participants. Those partnerships allowed our AAA Programs to operate in an agile structure that was focused on skill development and program flexibility.

In 2020-2021 the BC Hockey Female U18 AAA and Male AAA Programs used a 3-phase approach:

Phase 1

- July 29, 2020 to September 20, 2020
- Team Selection

Phase 2





- September 20, 2020 to December 20, 2020
- Skill Development and Gameplay
 - Teams had the opportunity to play exhibition games in October and November where they played against other AAA teams and Canadian Sports School Hockey League (CSSHL) teams. The CSSHL and AAA Leagues collaborated to provide athletes the maximum potential to complete within the guidelines set by the PHO.

Phase 3

- January 1, 2021 to April 30, 2021
- Skill Development and Mentorship
 - Team staff did a tremendous job being creative and finding new and unique ways to contribute to athlete development as well as their personal growth.

BC Hockey has worked hard to focus on member engagement and developing stronger relationships with other minor hockey stakeholders. We look forward to the continued collaboration and growth that comes from these partnerships.

Female and Male Program of Excellence (POE)

The 2020 Program of Excellence, Female and Male, was canceled due to the COVID-19 pandemic.

BC Hockey participated in the Hockey Canada Gold Medal Pathway task group to review national standards and best practices.

BC Hockey is constantly exploring all options and look forward to when we can operate the program to its fullest potential in the future.

Officiating Committee

Sean Raphael, Referee-in-Chief

The Officiating Program's leadership team embraced the challenges of the 2020-2021 season with optimism, engagement, support and enthusiasm. With a specific focus on both player safety in a COVID-19 environment and the role of officials in this endeavor, there was strong support with regard to was expected of the Officiating program. Unfortunately, due to COVID-19, the Summer Officiating Schools, OPoE, BC Cup, Mentorship Program and Championships were all cancelled for 2020-2021.

Throughout the summer of 2020 some primary resources were established for officials. Hockey Canada released a document for the Officiating program in August. BC Hockey followed up by establishing 'Points of Focus' that adhered to all BC Provincial Government and viaSport guidelines. All registered officials completed Hockey Canada's 'Panning a Safe Return to Hockey' online course via the eLearning platform, prior to clinic attendance and were provided the opportunity to complete certification for the 2020-2021 season by way of online clinic delivery, via the Zoom platform.

This was the first-time online delivery was used for mass certification and in particular the delivery of training for minor hockey officials at Levels 1, 2 and 3. An adapted curriculum was established, with a condensed 2-hours education package. The primary additions to the curriculum included:

1. 2020-2022 New Hockey Canada Playing Rules





2. 2020-2021 Points of Focus

- a. Altercations
- b. Interference / Protection of the Goaltender
- c. Face-off Procedures (player proximity / physical distancing)
- d. Player Safety: Head Contact, Checking from Behind, Restraining Fouls, Stick Infractions, Spitting and Harassment of Officials

New officials were provided the opportunity to join the officiating program through MHA hosted in-person clinics, delivered by their local Referee-in-chief. These clinics adhered to all Provincial Health Orders and the usual mandatory instructional ice session was made optional. The curriculum for new officials was pre-recorded during the summer for an easy 'click and play' delivery method. This not only made the material available during a period where travel of instructors was challenging but it also provided a consistent form of messaging and delivery of content. Additionally, an introductory option was made available through a pilot program for first-time officials interested in U9 / Half-ice. Officials participating in this pilot program paid a significantly reduced registration fee (\$25.00), received a condensed curriculum focused on U9 game play and qualified as 'trained' rather than 'certified'. Officials participating in this pilot were also permitted to register a year below the current minimum age of 12, with a pathway to Level 1 for next year.

Once the season was underway, games began in some areas as early as late September and all registered officials were provided with a face covering (non-medical grade) to assist in their ability to meet Public Health and viaSport guidelines. Unfortunately, due to ongoing Public Health Orders, game play was paused throughout the Lower Mainland in mid-November and across the Membership by early December. Despite being able to provide significant certification opportunities successfully, by mid-December the vast majority of officials had lost all opportunities to participate for what would be the rest of the season.

Once it was clear in early December 2020 that game play was on hiatus, the Officiating program increased opportunities to engage with officials through various virtual means. In early December there was a video conference for all High-Performance officials, advising them of the state of their various leagues. By mid-December six (6) BC Hockey Officials had been selected to participate in the World Junior Hockey Championship in the Edmonton bubble. Those officials provided the BC Hockey Officiating Program with a look inside that event by joining a live webinar that was made available to all officials, prior to the tournament in the form of an interview panel. During the Gold Medal game, the Officiating program hosted live broadcast of the game, providing commentary on the officiating aspects of the game and were joined by two (2) Level 6 Referees from previous world junior competitions, as well as Referee Michael Campbell live from Edmonton only hours after officiating the Bronze medal game earlier that day.

As 2021 began, it became clear that a return to game play was unlikely. So, throughout the remainder of the season the Officiating program stayed extremely active on social media with additional opportunities to engage with officials. Through January and February there were three (3) interactive learning session delivered. This was focused on rule knowledge, officiating procedures and general officiating trivia. These sessions were live contest-based using the Kahoot platform, with the top performing participants receiving various BC Hockey prizes. Family Day, Valentine's Day and Black History Month were all featured through various online campaigns in February by featuring BC Hockey participants an alumni. Additionally, the 2021 Hockey Canada Officiating exam was posted online in the form of another contest, again the top performing officials receiving BC Hockey prizes. By International Women's day the Female



High-Performance Officiating highlighted various development sessions that had been occurring all season.

With late season developments leading to the WHL and BCHL returning to play, many BC Hockey officials prepared to return to the ice. They were informed of the necessary safety protocols and logistical guidelines, in addition to six (6) regionally based training ice-sessions, over spring break. The bittersweet nature of only a few officials returning to the ice, led the officiating program to continue through the spring with various off-ice fitness tests, challenges and tracking contests via Twitter and Strava.

In early April, BC Hockey officials were advised via memo about an updated Hockey Canada Officiating Program Pathway, in addition to information regarding a significantly reduced registration fee structure for the 2021-2022 season for all those officials registered during 2020-2021 season, due to the impacts of COVID-19. Through support from the BC Hockey Board of Directions the following registration subsidies will apply for 2021-2022.

Player Development Advisory Group

Dave Cunning, Manager, Athlete Development

Player Pathways

2020-2021 was the first year of mandate for the U11 Pathway. Built on the successes of the U7/U9 Pathway programming, the Hockey Canada U11 Pathway is the next phase in player development and outlines an optimal seasonal structure, age-appropriate development guidelines and guiding principles, as well as key recommendations, all focusing on the appropriate development for nine (9) and 10-year-old players. The pathway also aims to deliver a positive experience during tryouts by providing pre-tryout ice sessions and avoiding tryouts during the first week of school, which traditionally can be a stressful time for players and families as they transition into new classrooms, friends, and teachers. This plan is all about allowing players the best possible opportunity to present their best selves in an evaluation environment.

Return to Play Off-Ice Alternative Training Plan

Understanding that ice time availability had the potential to be limited during the 2020-2021 season, and that coaches might need to deliver fundamental skill development in an environment other than on-ice, BC Hockey collaborated with Aaron Hoffman in developing a collection of off-ice training packages that aligned with Hockey Canada's "Alternative Skill Instruction" resource, which was distributed to membership before the season started. This collection sought to provide coaches with supplemental skill sequences via the Hockey Canada Network App and the BC Hockey YouTube channel that coaches could adapt to an off-ice scenario when on-ice training opportunities were limited. The project boasted 42 original videos in the areas of Shooting & Scoring, Passing & Receiving, and Goaltending, and received over 1,200 total views while also reaching 175 participants through the Hockey Canada Network App.

As we head into the 2021-2022 season we hope that we will be able to continue to work through many important safety initiatives.

School Programming

Dave Cunning, Manager, Athlete Development

Hockey Canada Skills Academy (HCSA)

415 participants took part in one (1) of the 15 BC HCSA programs in 2020-2021 – this is just under half of the number of HCAS operators we fielded in 2019-2020, and a subsequent 50% drop in participant registration from last year. All HCSA operators were required to file a Return to Play plan with BC hockey, outlining their unique safety plans and adherence to Phase 2 activities.

Hockey Canada Accredited Schools (HCAS)

2020-2021 was the first full year of the revised HCAS Policy's implementation. This education-first focused document guides the standard of experience for participating student-athletes and helps navigate operators through the renewal and new application process.

BC Hockey delivered four (4) Sport Quality Observations (SQO) via Zoom for operators who received probationary status upon renewal application in 2019-2020. After our assessment of these programs through the SQO process, all four operators were granted a full three-year renewal, and had their probationary statuses removed.



8 CSSHL operators fielded 41 teams stocked with 854 players across 8 divisions in 2020-2021. Outside of CSSHL HCAS programs, The Fernie Academy and Shuswap Academy deferred their operations to the 2022-2023 season.

High School Hockey League

Due to the ongoing COVID-19 pandemic and the BC Provincial Health Officer (PHO) order which did not allow team sport competition nor travel for sport, the 2021 BC High School Hockey League was cancelled for the second consecutive year. Plans were in place to run the eleventh BC Hockey High School Hockey League (BCHSHL) season, and the 20 teams from the previous season were polled for their interest and ability to compete in the league in 2021 if gameplay were allowed – only 14% responded affirmatively, while 43% replied as unable or not in favor (24% were unsure of their school's capability, 14% did not reply).

Post-cancellation, feedback from league operators was encouraging and optimistic, and all were committed to seeing the program successfully return next season. Reports from operators indicate that players appear keen to play in this league, and the operators themselves are equally enthusiastic about providing this program to their students. We hope to be able to offer the program again in 2022.
